
Sir,


The college authority should fulfill the following terms & conditions :-

- 1) The college building should be completed in all respects within a year.
- 2) Library books should be purchased in sufficient numbers to meet the requirement of the students.
- 3) The intake will be restricted to 150.
- 4) The admission of students shall be made strictly on the basis of merit following the guideline of the University.
- 5) Teaching and Non-teaching Staff should be appointed as per norms stipulated by the State Govt. and the University of Burdwan.
- 6) The Governing Body of the college will be constituted at the earliest as per St. 3(GB) of Burdwan University Statutes relating to Constitution, Power and Functions of the Governing Body of affiliated colleges other than Govt. Colleges. Pending that, the college will be run by an ad-hoc G.B. duly approved by the University.
- 7) The fees structure shall be as per norms of the University and Govt. of West Bengal.
- 8) The organizers shall abide by the Act, Statutes, Ordinances, Rules and Regulations etc. of the University of Burdwan as are in force and as may be amended from time to time in connection with affiliation, administration, appointment, academic activities etc. of the affiliated colleges.
- 9) The College should be inspected by an Inspection Team of the University of Burdwan within a short period.
