Functions

Grievance Redressal Mechanisms (GRM)

- Grievance Redressal Mechanisms (GRM) in colleges are structured processes designed to
 resolve complaints and issues raised by students, staff, or faculty members. A wellimplemented GRM ensures that grievances are handled promptly, fairly, and
 transparently. Here is a typical structure for a grievance redressal mechanism in a college;
- Grievances can be submitted through various channels such as online portals or email, suggestion/complaint boxes placed in various locations on campus, direct submission to committee members.
- To review and resolve grievances submitted by students or staff there is well structured grievance committee.
- Grievances should be documented, including the complainant's details, date of submission, and a detailed description of the issue.
- After screening or preliminary review to determine if the grievance is valid and within the committee's purview, the grievance is supposed to be addressed within a specified timeframe (e.g., 24-48 hours).
- The fact findings are usually done by collecting relevant information, interview involved parties, and review any supporting documents.

Through the entire process maintaining confidentiality is the foremost principal.

- After the facts findings the committee should conduct a meeting to discuss the findings and decide on a resolution.
- The decision thereafter been communicated to the complainant in writing or verbally whatever is rational then including any steps to be taken and a timeline for implementation.
- The committee even provides another option for the complainant to appeal the decision if they are not satisfied with the outcome
- The feedback is taken from the complainant on the resolution process and its effectiveness.
- The committee use to conduct awareness programs to educate students and staff about the grievance redressal process.
